**UNCONFIRMED MINUTES**

**A meeting of the Council was held on Tuesday, 3 March 2015 in the Reading Room, Llanon.**

Prior to the commencement of the meeting, the Chairman gave a brief outline of the meeting held to interview 2 candidates for the post of Clerc/RFO and the subsequent appointment of, and decline, by the successful applicant. A formal note is attached of those minutes.

The meeting commenced at 8.00 p.m and in the continued absence of a Clerc, Cllr M Lawton agreed to take the Minutes.

- 1. Apologies / Personal Matters / Disclosure of Personal Interests.**

- 2. To confirm the Minutes of 3 February 2015 Meeting.**  
The Minutes were confirmed as correct.
- 3. Matters arising from the Minutes.**  
**3(d)** The two bottle banks in the car park were full but steps had been taken to have them emptied – usually the banks are emptied each week but occasionally a visit is missed. It was agreed to monitor the situation before considering a third bank and to contact Ceredigion County Council to try to ensure weekly emptying.
- 3(e)** Councillor Lewis reported that Epson do a freestanding projector at a cost of £300.

- 8(c)** Roedd adroddiad parthed y cyfweiliadau ar gyfer Clerc newydd ynghlwm.
- 9(a)** Fe gynhaliwyd cyfarfod yn y White Swan ar 25 Chwefror lle y bu i oddeutu 60 o bobl ddod ynghyd. Rhoddwyd cyflwyniadau gan Michael Morgans ac roedd Sioned Evans, Cadeirydd Cyngor Tref Cei Newydd hefyd yn bresennol ac wedi cytuno cynorthwyo gyda hyfforddiant, pan oedd angen. Yna dilynodd trafodaeth a dywedwyd fod Pwyllgor y Carnifal yn noddï cost un deffribiliwr gan gyfrannu £500. Fe fu i ddau addewid o £100 gael eu gwneud ar y noson ac fe fu i 38 o bobl gofrestru ar gyfer cael eu hyfforddi. Caiff pwyllgor ei sefydlu i'w gadeirio gan y Cynghorydd G Lewis. - 3(g)** A letter of thanks has been sent to the previous clerk who has agreed to continue helping out until a permanent replacement is found. She has asked to submit her expenses and an hours spent claim for payment.
- 3(i)** County Councillor Edwards has the matter of the aftermath of Rose Mount overgrowth under enquiry and will report back at the next meeting.
- 4(a)** Councillor Morgan had been to look at the broken bench and has now repaired it to a good standard. The Chairman thanked Councillor Morgan for his good work.
- 4(c)** Regrettably as yet no details of the replacement bench have been passed to Maes Gwyn farm for agreement / discussion but steps will be taken to remedy this.
- 5(e)** Cheques and covering letters to all applicants for financial assistance as per Appendix A of the minutes will be sent out after the current meeting.
- 8(b)** Apparently the lease signed by the Chairman was not in itself sufficient but more documents had been obtained, signed and witnessed and the matter was now settled.
- 8(c)** A report regarding the interviews for a new Clerk is attached.
- 9(a)** A meeting was held at the White Swan on 25 February where approx. 60 people attended. Demonstrations were given by Michael Morgans and Sioned Evans, Chair of New Quay Town Council, also attended and agreed to assist with training when needed. Discussions then followed and it was reported that the Carnival Committee would sponsor the cost of one defibrillator and would donate £500. On the night two specific donations of £100 were also pledged and 38 people signed up for training. A committee is to be formed chaired by Councillor G. Lewis. All monies received will be held by the Community Council and ring fenced. Progress reports will be given at each Community Council meeting. The Chairman of the Community Council had thanked everyone for

Ms. N Lovaro, who organises tennis lessons, practice and equipment, was present at the meeting and expressed some concerns regarding exactly what would happen regarding the resurfacing and it was suggested, and agreed by her, that when the work is scheduled to start she will be involved in liaisons with Mr Standing. The Chairman thanked Ms Novaro for her interest and for volunteering to assist.

The County Council has quoted £65 + VAT to kill off the weeds on the courts.

**10. Dyddiad y Cyfarfod Nesaf**  
Nos Fawrth 7fed Ebrill 2015.

Daeth y cyfarfod i ben am 9.50 y.h.

After the success of the meeting held on 25<sup>th</sup> February at the White Swan, it was proposed by Councillor Lloyd and seconded by Councillor James that the Community Council donate £500 to the fund created to obtain two defibrillator and storage containers. The Community Council was asked to oversee the funds and to include them, ringfenced in the accounts etc. Accordingly, reports will be brought to each meeting as to progress made.

- (b) Councillor Hayfield suggested that a representative from Openreach be asked to attend a meeting to explain delays. After discussion, it was decided not to proceed.
- (c) It had been reported that rubbish had been left outside the Central Hotel/Chinese Restaurant both of which are now closed. Contact to be made to the Receivers to ask for the rubbish to be cleared.
- (d) The owner of the Chip Shop had asked if he could use the beer garden, no longer used by the Chinese Restaurant, for his customers. Agreed.
- (e) 'Dog fouling' signs, previously obtained by the Community Council, have not yet been erected. Councillor Reed offered to assist in displaying them.
- (f) The Chairman reported that a potential new Clerk to the Council hoped to attend but had been prevented by a family bereavement. After discussion it was decided to ask the applicant to attend an informal meeting with the members of the Community Council prior to the next meeting.
