It was also noted that the County Council was going to use the scheme as an example of good practice on its website.

Consideration was given to a request that the Council provide an allotment in Llanon / Llansantffraed either on its own land or by facilitating the use of other land. During the discussion, it was agreed that the Council did not own suitable land and that owners of other parcels of land in the Community be approached for this purpose.

It was **RESOLVED** to approach landowners in both villages, including a slang near the coast, land behind Seilo Chapel and land behind the Primary School.

514 Stryd y Capel Sign

Consideration was given to a suggestion for erecting a sign on a wall on the southern side of the entrance to Stryd y Capel, which had not been erected to date. It was stated that the ownership of the property of which the suggested wall formed a part was in doubt. Following discussion, it was **RESOLVED** to discuss the matter with the County Council.

515 Any Other Competent Business

The Chairman referred to the following.

- a) Publishing of minutes – it was agreed to request the Clerk to arrange for the draft minutes to be circulated to Members and placed on the noticeboards as soon as possible after meetings.
- b) Should Welsh Government regulations and guidance be changed prior to the date of the next meeting, 4th August, to allow meetings to take place within premises, to request Capel Seilo whether the vestry could be used for this purpose.
