573 2021-22 Budget, Precept and Council Tax

It was **RESOLVED** to arrange to approve the annual budget and set the Precept and Council Tax for 2021-22 at the next meeting to be held on 5th January 2021.

574 Footpath at Stryd y Capel
It was noted that the previous contractor was unable to undertake the work and it was **RESOLVED** to request the contractor who cleared the Morfa beach of stones to undertake the work.

575 Land at the Entrance to the Waun Car Park
Members discussed the matter further and it was **RESOLVED** not to develop the land for any purpose.

576 Memorial Bench on the Council's Slang
Further detailed consideration was given to this matter, including a timeline produced by the Clerk.

In the first instance, the Clerk was advised by Members that part of the timeline was incorrect and the corrected information was discussed.

In particular, the work identified in the August 2019 Schedule for this bench, namely "*Re-anchor bench to the concrete base. Treat, sand and re-paint*" was carried out by the contractor during the contract undertaken in January-March 2020. No additional repairs were identified at this time.

However, it appears that the condition of the bench deteriorated badly between the date of the work and July 2020. It was at this time that Councillor Philip Tomlins contacted Mrs Juliet Morgan about the condition of the bench, informing her that it was in a very bad condition and needed immediate attention. The bench was removed from its base by the Councillor

for safety reasons and the plaque given to Mrs Morgan for safe-keeping. It is understood that the family did not take any action with regard to the bench at this time.

In conclusion, the Council felt that it was satisfied that it has treated this bench in exactly the same way as it treated all the other benches in the Community. The bench had been attended to by the contractor in accordance with the work identified in the schedule. The bench was found to be in a sturdy condition during the inspection and at the time of the work. Furthermore, the Council felt that it couldn't be held responsible for the condition of the bench deteriorating during the weeks immediately following the work and that it took immediate steps to inform a member of the family of the situation.

As resolved previously, the Council had agreed to fund a replacement bench at this location for the benefit of the community, and allowing memorial plaques to be placed on it, including this particular plaque.

It was **RESOLVED** to write to Ms Foster advising her of the Council's decision.

577 Request for a Community Allotment
Consideration was given to the Report of the Clerk on the procedure for dealing with requests to provide a community allotment, including the relevant legislation.

Members noted again that it had no suitable land for this purpose and gave further consideration to possible land in the Llanon and Llansantffraed area.

It was **RESOLVED** to request the Clerk to contact the owner of land situated at the top of Stryd y Capel for this purpose.
