784 Matters arising from the Minutes

788 Meinciau

Cyfeiriodd y Cynghorydd Dennis Morgan at gynrychioladau a dderbyniwyd ganddo oddi wrth drigolion yn stad Cylch Peris parthed colli dwy fainc ac os fyddai'r Cyngor yn ystyried prynu rhai yn eu lle. Dywedodd y Clerc, tra fod gan y Cyngor bŵerau i ddarparu meinciau er lles y gymuned, nid oedd y Cyngor yn berchen y tir hwn ac y byddai darparu meinciau fan hyn yn gosod cynsail ar gyfer delio gyda cheisiadau o'r fath yn y dyfodol. Dywedodd y Cynghorydd Dafydd Edwards, yn ddibynnol are eu lleoliad, dylai'r Cyngor gysylltu â'r Cyngor Sir a Barcud ill dau

annual inspection held recently. A quotation for both the costs of the materials and labour costs had now been obtained and were outlined in the Report.

It was **RESOLVED** to accept the quotation provided by Wicksteed, as specialist contractors, in the sum of £3,306.60 and to request them to undertake the work as soon as possible.

786 Council's Slang

Councillor Gwenno Piette outlined the action taken with regard to the painted pebbles which formed part of 'Monty Sid'. People had been advised to take away any of theirs and the remainder would be disposed of as their condition had deteriorated and not in a good enough condition to be permanently displayed.

787 Footpaths

Councillor Gwenno Pipette stated that she and Councillor Sheila Davies had recently met with Gareth Owen, the County Council Footpaths Warden, with regard to several matters, including:

- the placing of replacement way signs
- clarification of the route of footpath 33/27 leading from Glyn Cottage to Lain Prys.

Councillor Davies also reported that the first cut had been completed.

788 Benches

Councillor Dennis Morgan referred to representations he had received from residents in the Cylch Peris estate about the loss of two benches and whether the Council consider buying replacements for them. The Clerk advised that, whilst the Council had the powers to provide benches for the benefit of the community, this was not Council-owned land and that providing benches here would set a precedent for dealing with future requests of this kind. County Councillor Dafydd Edwards stated that, depending on their location, the Council should contact both the County Council and Barcud in respect

792 Queen's Jubilee Celebrations

Councillor Bryan Tomlins reported the outcome of the two public consultation meetings held in order to gauge the degree of support within the community for holding an event of any kind. He stated that six had attended the afternoon meeting on 16th March who had indicated that, whilst they could not undertake to take part in the organisation of any event, they would be prepared to support any organising committee that could be established at the meeting being held that evening. Unfortunately, no member of the public attended the evening meeting.

Members resolved that it had to be accepted that this showed there was no support for organising such an event within the community and it was **RESOLVED** not to proceed any further with the matter.

793 Any Other Competent Business

Councillor Phil Tomlins updated Members on the following matters:

- a) the Aberaeron and District Swimming Pool, had successfully obtained a grant of £200,000 for the cost of replacing the heating system and upgrading the changing rooms.
- b) two residents of Llanon, Rachel Jones and Ron Pateman, had agreed to take over responsibility for the defibrillators in the village.
- c) he had referred recent instances of rabbiting to PCSO Charlotte Carter. Councillor Dennis Morgan was requested to request Enzos to clear the Morfa car park and for an update on providing dropped kerbs.
