13 Matters arising from the Minutes

- a) Minute 784c) Land in the Nebo area. The
Clerc reported a list of deeds received
from Evans & Davies, the Council's
Solicitors. It was noted that there was no

RESOLVED to make further enquiries.

14 Monthly Inspection

Councillor Sheila Davies reported matters and it was agreed as follows. To contact the contractor to enquire whether he could treat the weeds on the tennis courts and cut the growth adjacent to the Waun car park. There were no matters to raise in respect of the condition of the slang and the seating area. The inspection rota would need to be produced for 2022.

15 Playground

The Clerk was requested to contact Wicksteed to ascertain when the repairs would be undertaken.

17 Footpaths

The signs had been received and would be put in place shortly. The County Council Footpaths Warden, Gareth Jones was taking action in respect of the blocked footpath which was still the subject of complaints. It was agreed to clarify whether cycles were allowed on the coastal footpath.

20 Future Meetings of the Council

The programme of meetings for the 2022-23 municipal year was approved.

Consideration was given to the request of Councillor Lodwick Lloyd that the Council revert to meeting in the Reading Room. Members felt that the current venue was more suitable for holding meetings.

The Clerk referred to the requirement of the Local Government and Elections (Wales) Act 2021 for Councils to hold multi location meetings and that he knew of one Clerk who was holding meetings at the local Community Primary School as it contained resources to enable remote attendance to take place.

It was **RESOLVED** to continue to meet at the current location and to request the Clerk to contact the Headteacher of the Llannon County Primary School as to the possibility of using its hall for future meetings.

21 Any Other Competent Business

County Councillor Keith Henson stated that he had attended a meeting earlier that day in respect of the proposal of the Welsh Government to replace 30 mph speed limits with 20 mph speed limits. It was noted that Town and Community Councils would be consulted on the proposals.

Councillor Dennis Morgan stated that he had discussed matters relating to replacing dropped kerbs, clearing Morfa beach and the provision of a community noticeboard at Stad Craog Ddu with Enzo's.

The meeting concluded at 8:45pm
