The Clerk reported an e-mail dated 2nd November from the Secretary to the Llanon Village Hall and Playing Field Committee stating that they would not be considering the Council's request to acquire the playing field until matters in respect of the changing rooms and with the Charity Commissioner had been resolved and it was **RESOLVED** to note the present position and await their decision.
It was also agreed to remind the Committee of the necessity to keep the gates to the field locked in order to prevent its unauthorised use.

- c) In reply to Councillor Roberts, the Clerk advised that nothing further had been heard from the Welsh Government in respect of the introduction of parking restrictions on the A487 in Llanon.

- d) It was agreed to request the Village Hall Committee to remove the chain-link fence on the boundary of the car park, as its continued need was questioned, and that it posed a danger to pedestrians.
- e) Community Champion 2020 - It was agreed to organise a competition this year in line with last year's competition and to invite nominations via e-mail by way of a notice in the Llansantffraed and Nebo Facebook page and a voting box at the village shop.
