To note the conditions required by the statutory consultees to be placed on any approval of the application by the Local Planning Authority and to seek assurances that the Authority ensures that these are met prior to the development being completed.

b) INV240119 Potential breach of Condition 11 attached to planning permission A041235 (Reserved Matters approval for the erection of a dwelling), whereby the approved footway verge has not been completed at Llys Yr Esgob, Stryd Yr Eglwys, Llanon, Ceredigion, SY23 5HT.

Information received from the Enforcement Officer:

A desk-based investigation was undertaken regarding the failure to complete the approved footway verge, as required by Condition 11 of planning permission reference A041235.

Following a review of the planning history and available records, it has been established that the breach of planning control, specifically the failure to complete the approved footway verge, has existed for a period exceeding ten years. Under Section 171B(3) of the Town and Country Planning Act 1990, any breach of a planning condition becomes immune from enforcement action after a period of ten years has elapsed since the breach first occurred.

As such, the time limit for taking enforcement action has expired, and the development is now considered immune from enforcement action through the passage of time. Consequently, the Local Planning Authority no longer has statutory powers to secure compliance or to require the pavement to be completed in accordance with the approved plans.

This compliance case has therefore been closed, and no further action will be taken with regards to this matter.
