The Chairman welcomed PCSO Charlotte Carter to the meeting.

- b) Community Speed Watch scheme and other traffic matters. The Council was advised that such a service could be provided. Reference was made to the expected introduction of a 20mph speed limit on the A487 which would hopefully reduce speeding. Consultation on a proposed on road parking restrictions was imminent. Councillor Henson stated that he had requested the possibility of providing bus stop markings on the road opposite Heol Non Llanon. PCSO Carter stated that reinstating damaged cones in this area was too expensive.
