- a consultation exercise would be held soon on the number of polling stations
- an approach had been made with regard to the possibility of the Council acquiring the piece of land adjoining the Museum Cottage.

**231 Any Other Competent Business**

The Clerk stated that the Council was being requested by the Trustees of the Cross Inn School House for support for their decision to sell the now vacant property and for the proceeds to be used, in accordance with the original Trust Deed, by an educational charity in the area.
