### 293 Ymddiheuriadau

### 294 Dyfed-Powys Police

The Chairman welcomed to the Meeting PCSO Charlotte Carter who reported the following.

- Siaradwyd gyda reidiwr beic a oedd yn beicio o gwmpas Llanon ac edrychai ei fod wedi talu sylw l'r cyngor a roddwyd iddo
- Roedd beic modur wedi cael ei ddwyn yn llanon
- Roedd ymddygiad amheus dyn yn y pentref yn cael ei ddilyn i fyny
- Roedd dau digwyddiad arall wedi digwydd ar yr A487 rhwng llanon ac Aberarth
- Ymarferiad Speedwatch posib – byddai angen casglu tystiolaeth er mwyn trefnu ymarferiad
- Gellid trefnu sesiwn galw mewn gyda'r Heddlu mewn cysylltiad a'r Fan Pobl Ifanc ar 26ain Mawrth.

- A motorcyclist riding around Llanon had been spoken to and appeared to have heeded the advice given to him
- There had also been a theft of a motorcycle in the village
- The activities of a suspicious male had also been followed up
- There had been a further two incidents on the A487 between Llanon and Aberarth
- Possible Speedwatch exercise – evidence of speeding would need to be collected in order to get an exercise organised

  - nid oedd unrhyw ymgynghorai staudol wedi gwrthwynebu ond fod pob un ohonynt wedi gosod amodau cadarn ar y ddatblygiad gorffenedig
  - roedd y trigolion oedd yn ffinio gyda'r cefn lle y byddai'r lle MOT a'r gweithdy l'w lleoli wedi ail-ddatgan ei gwrthwynebiadau l'r datblygiad

- 296 Minutes of the Meeting held on 6<sup>th</sup> February 2024**  
It was **RESOLVED** the Minutes of the Meeting of the Council held on 2<sup>nd</sup> January 2024 as being correct subject to, with regard to Minute 289 – Planning Application A230865 – to note that the decision was to await consideration of the comments of the statutory consultees.
- 297 Matters Arising from the Minutes**  
**Minute 285** – it was noted that the Llanon Village Hall Committee had decided to agree to allow EV chargers to be located in the Hall car park and that income would be received in respect of this.  
**Minute 289** – planning application A230865. The clerk reported that the consultation period had ended and that he had ascertained the following:
- the application was similar to the two previous planning applications
  - no statutory consultee had raised any objection but all of them had placed strict conditions on the completed development
  - the neighbouring residents at the rear where the MOT station and workshop were to be located had re-iterated their objections to the development.
- It was **RESOLVED** to note the conditions required by the statutory consultees to be placed on any approval of the application by the Local Planning Authority and to seek assurances that the Authority will ensure that these are met prior to the development being completed.
- 298 Llanon Museum Cottage and Garden**  
Councillor Keith Henson reported on the recent site visit with Carrie Canham, the Ceredigion Museum Curator, and Steve Christian, the Chairman of the Llansantffraed History Society. The following had been agreed and were being progressed by the Clerk:

### 302 Playground Extension Update

The Clerk reported that the paperwork for the transfer of the land was being completed and that the fee which had been paid - referred to in Minute 300 above – had been part of the transaction. Once the Transfer had been completed he would contact the playground equipment and fencing contractors to ask them to update their original prices due to the length of time taken to complete the land transaction and give the go ahead for the work to proceed.

### 303 Ceredigion County Council Budget matters:

The clerk reported as follows:

- a) **Waun toilets.** The County Council had advised that it would be formally contacting this Council in due course asking it to consider taking responsibility for the Waun toilets.

It was **RESOLVED** to note the situation at present, to await formal notification and to seek clarification of certain matters including staffing and maintenance costs prior to any decision being taken.

- b) **Ground maintenance.** The County Council had advised that it would be formally contacting this Council in due course to consider taking responsibility for cutting grass in certain areas in its ownership in Lanon and Llansantffraed. Maps of the land in question were circulated at the meeting.

It was **RESOLVED** to note the situation, to await formal notification and to seek clarification of the details of some of the land under consideration.
