The Chairman welcomed PCSO Charlotte Carter to the meeting and the following information was reported. There had been ten road traffic collisions on the A487 between Aberarth and Llanon during the previous two months and there were on-going discussions with the Trunk Road Authority in respect of possible improvements in the vicinity of the double bend. There had been recent instances of rabbiting late at night using strong lights and which probably involved trespassing. There had been break-ins to empty houses in Llanon. PCSO Carter stated that evidence of incidents of speeding in Llanon would be needed in order to build a case for a GoSafe exercise.
