The Clerk advised that, with the 2024-25 accounts being finalised, there were sufficient funds to proceed with the scheme and it was **RESOLVED** to place an order with the successful tenderer, namely Urban Recreation for the supply of a tunnel, swing and play panels in the sum of £12,500.

**488 Waun Storeroom Electricity Supply**

It was noted that the MPAN had now been received from National Grid and it was agreed to proceed to arrange for a supply to be provided to the storeroom.

**489 Tennis Courts**

a) The Clerk stated that arrangements were being made to visit the newly provided MUGA at Penrhyncoch to enable Members to view the facility. He stated that the first steps to be undertaken with regard to making a possible application for funding was to complete an Expression of Interest form which included the need to obtain support from local organisations for such a facility.

b) It was **RESOLVED** to accept the quote for the upgrading of the white line marker and that it be ordered.

**490 Morfa Beach**

Consideration was given to the price of £1,000 received for clearing the beach of stones that had been washed there. The Clerk reminded Members that the area was not owned by this Council and that there was no requirement for it to be kept accessible for people to use it. He was therefore recommending that it the number of people who could benefit from the work would justify spending a sum of this kind.
