532 Report of County Councillor Keith Henson

Councillor Henson reported as follows:

- He had requested Rebus to discuss the provision of a sign for the village hall at the junction of y Stryd Fawr and Stryd y Neuadd
- The matter of the responsibility for cutting grass in different areas of Cylch Peris still needed solving
- He was continuing to attempt to get permission to site a defibrillator cabinet at the Cylch Peris bus shelter
- To request the Clerk to proceed with the formal application for siting the bench at Cylch Peris at the agreed location.
