## 550 Planning Matters

The following matters were discussed

The Clerk outlined the way in which the planning application had been determined by the Local Planning Authority. It was noted that the Development Management Committee had upheld the recommendation of the Site Inspection Panel to approve the application subject to a number of stringent conditions, despite it being recommended for refusal by the Planning Case Officer.

Members noted the concerns of the residents of neighbouring homes and it was agreed that this Council impress upon the County Council the need to monitor the development closely and to take enforcement action if any of the conditions are not met by the developer.
